2. How do you rate the candidate delivery side of your business? Why do you give it this rating?
3. What metrics do you track? (For example, % job orders filled, #1st interviews per placement, # sales conversations/ job order, etc.)
4. How and where do you track these metrics? Do you also keep these metrics by client?
5. How frequently do you review your metrics, interpret their meaning, and adjust strategies and tactics based on what you learn from them?
6. What applicant tracking system (ATS) do use? Do you search, document, and submit via your ATS or do you do some things outside of it? How satisfied are you with your results (1-10)?
7. What system do you use (ATS or CRM) to track and follow up with client prospects on a timely basis? How satisfied are you with your results?
8. What step-by-step process do you use to convert client prospects into active job orders?
9. What “sales scripts/frameworks” do you use on your initial calls with new client prospects?
10. On a 1-10 scale, how effective are these frameworks?
11. What percentage of your business is based on client exclusives vs competition with other recruiting firms?
12. What percentage of your business has an up-front retainer?

17. What percentage of your business is temp/contract?
18. What do you do to increase your recruiting industry skills and knowledge?
